MINISTRY UPDATE

Hon'ble Union Minister Shri C.R. Paatil Chairs 12th Meeting on Ganga Rejuvenation Efforts - September 11, 2024

On September 11, 2024, Hon'ble Union Minister for Jal Shakti, Shri C.R. Paatil, chaired the 12th meeting of the Empowered Task Force on Ganga Rejuvenation, attended by senior officials from various ministries and state governments. The meeting centered on a comprehensive action plan for rejuvenating the Ganga, focusing on initiatives under the Namami Gange program, including the reuse of treated water, biodiversity conservation, and pollution remediation.

Hon'ble Minister emphasized the importance of collaboration among stakeholders to monitor Ganga-related projects effectively. He called for timely

completion of ongoing projects and highlighted the crucial role of rural and urban sanitation in river cleaning efforts. A National Framework for the Reuse of Treated Water was discussed, with state governments encouraged to align their practices with national guidelines.

Additionally, the Minister noted the potential for tourism along the Ganga's banks to boost regional economies and stressed the need for urban river management plans. He also advocated for natural farming practices along the Ganga basin to support river rejuvenation efforts, reinforcing the commitment to collaborative initiatives to achieve the targets set for Ganga restoration.

Highlights from the 8th India Water Week 2024: A Focus on Collaborative Water Management - September 17-19, 2024

The 8th India Water Week (IWW) 2024 commenced on September 17, 2024, in New Delhi, inaugurated by the Hon'ble President of India, Smt. Droupadi Murmu, in the presence of distinguished guests, including Hon'ble Union Minister for Jal Shakti, Shri C.R. Paatil, and Hon'ble Minister of State for Jal Shakti, Dr. Rajbhusan Choudhary. The theme for this year, "Partnerships and Cooperation for Inclusive Water Development and Management," set the tone for discussions on water conservation as a critical resource for future generations.

During the inaugural ceremony, Hon'ble President emphasized the significance of water conservation, invoking ancient Vedic wisdom to highlight its timeless importance. She noted that empowering young minds with this knowledge is essential for fostering a culture of conservation.

Hon'ble Union Minister Shri C.R. Paatil addressed the

gathering, stressing the urgent need for collective action to address global water challenges. His remarks underscored the event's role in facilitating knowledge exchange among water experts and stakeholders.

Hon'ble Union Jal Shakti Minister Shri C.R. Paatil Reviews Swachhata Hi Seva 2024 Activities in Odisha - September 26, 2024

Union Minister of Jal Shakti, Shri C.R. Paatil, visited Odisha to assess the ongoing Swachhata Hi Seva (SHS) 2024 campaign. The Minister participated in tree plantation activities at Suando village, the birthplace of social reformer Pandit Gopabandhu Das, as part of the "Ek Ped Ma Ke Naam" initiative. He also visited sanitation projects and engaged with beneficiaries of the Individual Household Latrines programme at Bidyadharpur

village. The Minister praised Odisha's progress under the Swachh Bharat Mission (SBM), which has achieved 100% toilet access from a previous 12%. Swachhata Hi Seva Campaign 2024 - September 17 - October 1, 2024

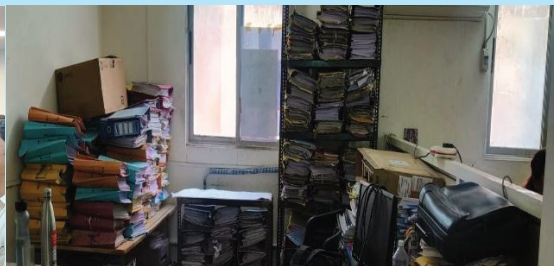

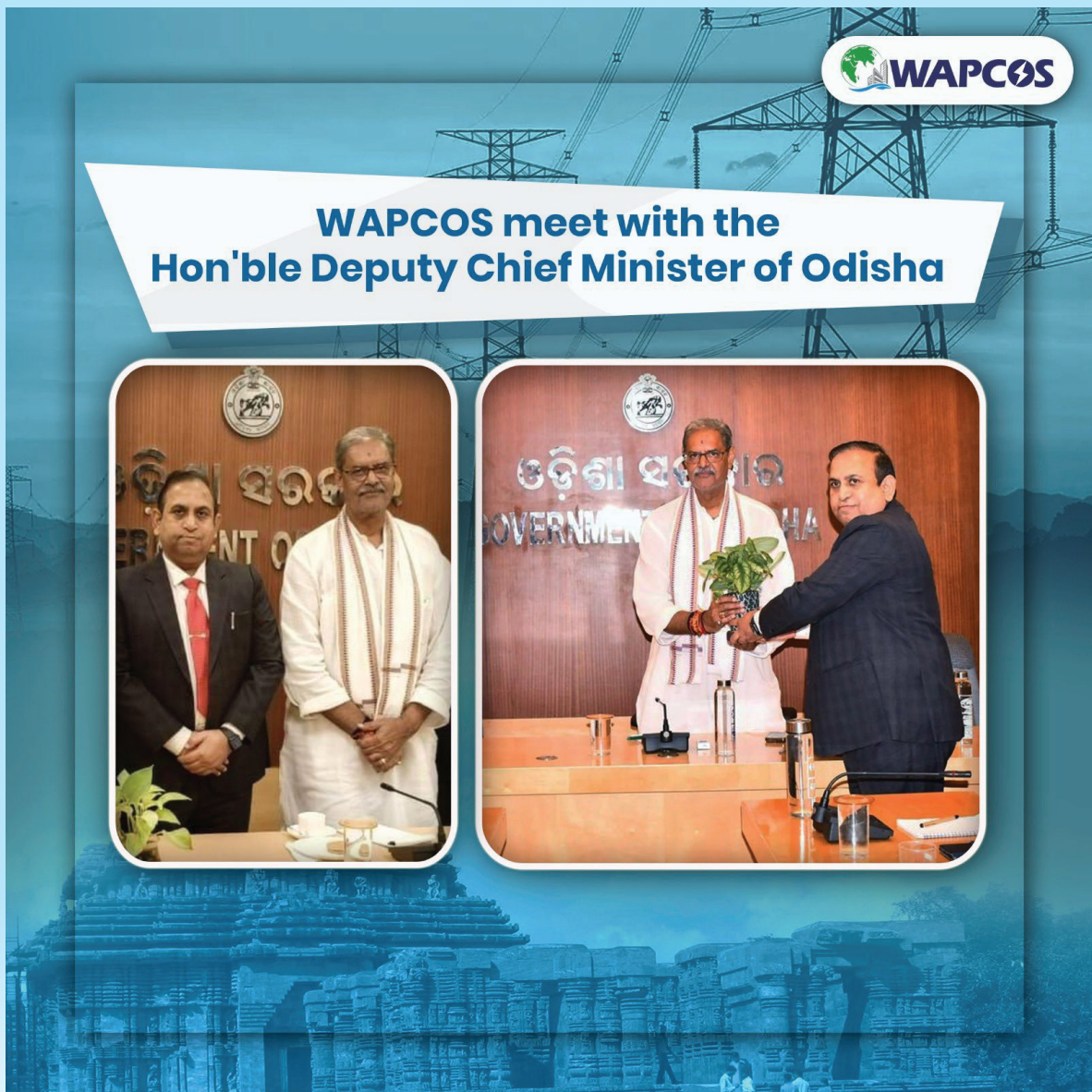
