# MINISTRY UPDATE

# International Conference on Dam Safety-2023 organised in Jaipur, Rajasthan

The International Conference on Dam Safety-2023 was a part of the Dam Safety Conferences series being organized under the Dam Rehabilitation and Improvement Project (DRIP). The Hon'ble Vice President of India, Shri Jagdeep Dhankhar inaugurated the International Conference on the theme 'Safe & Secure Dams Ensure Nation's Prosperity' organised by the Department of Water Resources, River Development, and Ganga Rejuvenation, Ministry of Jal Shakti at the Rajasthan International Centre (RIC) in Jaipur on 14th & 15th September 2023. The event brought together world-renowned experts and leaders in the field to enhance dam safety capacities.

At the inauguration of the two-day conference, the Hon'ble Vice President, Shri Jagdeep Dhankhar emphasised, "Safe and secure dams ensuring nations prosperity has great contemporary relevance." The Union Minister for Jal Shakti, Shri Gajendra Singh Shekhawat stated, "There are serious shortcomings in the maintenance of dams in India and so we need SoPs and common protocols for dam maintenance in India. We need to give importance to dam safety in coming years especially keeping in mind the changing patterns of climate. We need to also establish a joint task force soon to look into the various aspects of dam safety." He further added. "We have decided to make an interactive platform and take reference of case studies and best practices of dam safety and dam management to take things forward. This event is not the end but the beginning of many more future deliberations."

Various technical sessions were organised during the two-day conference to enable foremost experts and leaders in the field to strengthen capacities for enhancing dam safety. Various presentations were made during the plenary session starting with the sharing of Government of India Initiatives on Dam Safety and Management, followed by other presentations covering the topics of the Dam Safety Status of Maharashtra; Regulating Dam Safety within the Australian State of New South Wales (NSW) sharing valuable experiences from Australia; collaboration between Denmark & India on Water Management elaborating on the various collaboration efforts between the two nations; collaboration between Australia and India on Water Management highlighting bilateral cooperation in water management; and World Bank Initiatives on Dam Management providing insights into the World Bank's initiatives in the field.

Debashree Mukherjee, the then Special Secretary, DoWR, RD & GR, MoJS; Shri Anand Mohan, Joint Secretary, DoWR, RD & GR; Shri N N Rai, Director, Central Water Commission; Shri Ankit Kumar, DD, FE&SA, DSO, Central Water Commission; Mr Satoru Ueda, Lead Dam Specialist, World Bank; Mr Shane McGrath, Board Member, Dam Safety New South Wales, Australia; Mr Freddy Svane, Hon'ble Ambassador of Denmark in India, among others were present at the conference.

The conference was organised in collaboration with the Rajasthan Water Resources Department, the Central Water Commission, the National Dam Safety Authority, MNIT Jaipur, WAPCOS Ltd., the World Bank and the Asian Infrastructure Investment Bank.

# Vinyl-Wrapped Train Under National Water Mission (NWM) Flagged Off

On'ble Vice-President of India, Shri Jagdeep Dhankhar flagged off the vinyl-wrapped Kamakhya Express from Varanasi station via video conferencing on 14th September 2023. Under the 'Pani Ki Rail' initiative of the National Water Mission, two trains, the Himsagar Express & Kamakhya Express have been vinyl wrapped in collaboration with Ministry of Railways. This initiative aims to amplify the message of water conservation, river rejuvenation, and the significance of clean drinking water and sanitation. As these trains traverse across the nation, they will act as a moving billboard for promoting the vital message of water conservation and management.

This flagging off event was part of the International Dam Safety Conference 2023 held in Jaipur. Highlighting the intrinsic connection of India with water management, the Vice-President expounded that the Indian civilization has thrived for thousands of years on the banks of rivers, deriving life and sustenance from their waters. Addressing the august gathering, the Union Minister for Jal Shakti, Shri Gajendra Singh Shekhawat highlighted the diverse benefits of the dams and how they have been instrumental in India's water management, electricity generation, and flood control.

Emphasising the importance of dam safety, Shri Gajendra Singh Shekhawat spoke about the enactment of the Dam Safety Act in 2021 under the guidance of Hon'ble Prime Minister Shri Narendra Modi to ensure

key regulatory institutional framework and set of unified protocols for all dam owners.

Other dignitaries who graced the inaugural session were Shri Manik Saha, Chief Minister of Tripura; Shri D. K. Shivakumar, Deputy Chief Minister of Karnataka; Shri Mahendrajeet Singh Malviya, Water Resources Minister of Rajasthan; Smt. Usha Sharma, Chief Secretary of Rajasthan; and Shri Pankaj Kumar, the then Secretary, Department of Water Resources, RD & GR, Ministry of Jal Shakti. Foreign and national delegates and senior officers from various concerned departments were also present on the occasion.

## Objective:

- To provide water to the Deka rural communities through three tap-off points.
- The project's objective is to provide reliable water supply to Hwange Power Station from Deka Pumping Station through a 42 km pipeline.

## **Current Status of the Project:**

- Laying and Welding of Pipeline is completed for the entire 42 km
- Installation of Valves is 100% completed
- Construction of Valve Chambers is in progress
- Construction of Thrust Blocks is 100% completed
- Manufacturing of High Lift and Low Lift Pump &Motor is in progress
- Designing of Transformer and PLC & SCADA System is in progress

Client: Uranium Corporation of India Limited (UCIL)

## Objective:

The main objective of study is to assess the feasibility to increase the height of the Eastern and Western Dam for the tailing pond at Turamdih, East Singhbhum, Jharkhand along with detailed design engineering and tendering.

### Scope of Work:

The broad scope involves Data Collection, Site Visits, Review of Earlier Studies/Report, preparation of Feasibility Report, Design & Engineering Analysis, preparation of Design Basis Report, providing Technical Support for clearances, Engineering and preparation of Tender Document and providing Project Management Services.

## Main Components:

- Increasing height of Dams beyond EL 208m
- Construction of two new Dams on the Southern side of the tailing pond
- Realignment of both the roads on Northern and Southern side

#### **Present Status:**

Site visits were undertaken in May, 2023 and August, 2023 for collection of balance data, assessment of the gap and requirement of additional surveys & investigations in order to explore possible alternatives for raising of the Dam height.

# Preparation of Pre-Feasibility Report (PFR) and Detailed Project Report (DPR) for Sikaser Pumped Storage Hydroelectric Project, Chhattisgarh, India

Client: Chhattisgarh State Power Generation Company Limited (CSPGCL)

Location: The proposed site is located near Sikaser village of Gariaband district of Chhattisgarh, India

### Scope of Work:

The project is envisaged to be developed as Pump Storage Hydro Electric Scheme, utilising the available head between proposed upper dam and existing Sikaser reservoir as the lower pond. Both reservoirs will be interconnected through water conductor system and generator and turbines installed at underground power house.

The main scope involves preparation of Feasibility Report, Detailed Project Report and obtaining clearances from the statutory authorities including:

- · Collection of Data from concerned authorities
- Topographical Survey, Geological Investigations & Testing as per MOWR Guidelines
- Hydrology
- Power Potential Studies
- Environmental Studies
- Design of Civil Structures

- Upper Dam (Bund type) 4.3 Km long, 20 m High
- Water Conductor System of 1336m Length
- Net head of 322.47m
- Underground Power House of size 322 m x 22(W) m x 55(H) m
- Underground Transformer Hall of size 210 (L) m x 20(W) m x 28(H) m
- Installed Capacity 4 X 300 MW (1200 MW)
- Francis Turbines

## Present Status:

The Pre-Feasibility Report was submitted in July 2023.

Preparation of Form 1 of obtaining Terms of reference clerance from MOEF&CC is under process for carrying out the EIA/EMP studies.
