### India and Bangladesh signs MoU to share Kushiyara River waters

During Bangladesh's Hon'ble Prime Minister Ms. Sheikh Hasina's recent visit to India, the two nations signed a Memorandum of Understanding (MoU) on sharing of the waters of the Kushiyara River, a distributary of the Barak River which flows through Assam, and then on to Bangladesh.

The agreement comes at a time when deadly floods were witnessed both in parts of lower Assam and Sylhet in Bangladesh. This compelled the two nations to extend greater cooperation on flood control and irrigation-related issues. The sharing of waters will benefit people of both countries.



#### Andaman and Nicobar Islands declared as India's first Swachh Sujal Pradesh

Union Minister of Jal Shakti, Shri Gajendra Singh Shekhawat ji declared Andaman and Nicobar Islands as India's First Swachh Sujal Pradesh. An essential component of Sujal and Swachh is the management and supply of safe and secure drinking water.

All the villages in the Andaman and Nicobar Islands have now received the Har Ghar Jal certification. Along with this, they have also been verified as ODF (open defecation free) and ODF Plus.






# PROJECT UPDATE:

Preparation of Integrated Master Plan Infrastructure Design and Project Management Consultancy for BULK DRUG PARK at Jambusar, Gujarat

The Government of Gujarat intends to set up a Bulk Drug Park in Bharuch with the aim to promote bulk drugs, active pharmaceutical ingredients and critical pharmaceutical ingredients manufacturing, thereby moving strongly towards "Atmanirbhar Bharat" and support the Central Government's vision of improving India's position in the Global Value Chain (GVC).

WAPCOS has been appointed by Gujarat Industrial Development Corporation (GIDC) as Integrated Master Planner, Infrastructure Designer and Project Management Consultant for this project.



# BRIEF SCOPE OF WORK

Master Planning, Detailed Project Report, In-principle approval from Gol, assistance in finalization of tender and working as a PMC for different services like road, power supply, water supply, drainage amenities etc.

### **Project Status:**

- Master planning as per the guidelines including various common facilities and services/utilities such as water supply, roads, Centre of Excellence, CETP, TSDF, CSTP, warehousing, residential and commercial area completed and approved.
- Detailed Project Report submitted.
- Financial viability and commercial sustainability completed.
- Tender for Compound wall for the proposed project site published.

## THE SALIENT FEATURES OF THE PROJECT:

Project Location: Jambusar Taluka, Bharuch District, Gujarat

Site area: 2000 acres

#### **Achievements:**

- In context to the Guidelines of the Scheme "Promotion of Bulk Drug Parks",16 States across the country competed aggressively for the BULK DRUG PARK under the aforementioned scheme and presented themselves before the Advisory Committee headed by CEO NITI Aayog, Government of India, wherein Gujarat was one of the three states which finally emerged successful.
- Received In-principal approval for the grant-in-aid from the Government of India.



## PROJECT UPDATE:

Preparation of DPR, Construction of Artificial Recharge Structures and its Impact Assessment on Sustainable Groundwater Resources Creation in Mr12 & Mr13 Watersheds, Osmanabad Mandal, Osmanabad District, Maharashtra

The NITI Aayog on March 28, 2018 launched the baseline ranking for 101 aspirational districts based on 49 indicators across several sectors including health and nutrition, education, agriculture and water resources, financial inclusion, skill development and basic infrastructure. One of the districts falling under this program is "Osmanabad" of Maharashtra. The Ministry of Jal Shakti has entrusted the task of taking up the program of Artificial Ground Water Recharge in Osmanabad Mandal, Osmanabad District to WAPCOS as pilot project through Central Ground Water Board (CGWB).



- Formulation of Impact Assessment Strategies and implementation in time-domain during and after current monsoon period.


