In view of above , your bid value should be combined value for above two BOQ items. Since in GeM portal offer price screen doesn't reflects above two items properly, because selected category in GeM doesn't have option for hydrographic survey. As such, in-order to avoid any confusion the bidder should upload duly filled & signed in BOQ format given in the bid document. However to match the same value in offer price screen of GeM portal total value of the bid should be mentioned matching with uploaded duly filled & signed in BOQ format given in the bid document. Further since there is no digitisation work as per tender however it is appearing in the offer price screen of GeM portal, therefore unit rate against this item may be taken as Rs. 0.0001, so as to make negligible impact on the overall price of the bid to full fill the Gem Portal requirement and hence the full cost may be assigned against first item having quantity as 750 sq.km Lidar Survey.

For all future payments for the services will be made against two BOQ items given in the tender document.
