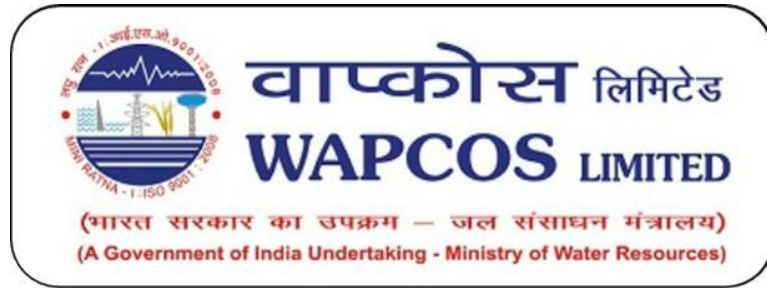

The bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). "Aspiring bidder who have not obtained the same from the website: www.pmgstendersuk.gov.in". Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.

3. **Submission of Original Documents:** The bidders are required to submit documents e.g. Affidavits for correctness of information as mentioned in the Tender Document, Bid Fee, Bid Validity, Bid Security (EMD), Bank Solvency Certificate etc. in original by Post or by hand in the office of Project Manager, WAPCOS Ltd, House No.209, Phase-I, Basanat Vihar, Dehradun, Uttarakhand upto **date 18.07.2024 upto 1:00 PM**, failing which the bids will be declared as non-responsive.
4. **Last Date/ Time** for receipt of bids through e-tendering **18-07-2024 01:00 PM**.
5. The site for work is available. The Bidder, at his own cost, responsibility and risk, is required to visit, examine and familiarize himself with the site of works. A Site Visit Certificate, duly issued by the Resident Engineer of PIU of WAPCOS, is required to submit by the bidder along with his bid, failing which, his bid shall not be considered to evaluation and shall be outrightly rejected.
6. **Bid Opening:** Only online submission of bids is permitted, therefore; bids must be submitted online on website www.pmgstendersuk.gov.in. The technical qualification part of the bids will be opened online on **18-07-2024 03:00 PM** by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time.
7. **Bid Validity:** The bids for the work shall remain valid for acceptance for a period not less than **90 Days** after the deadline date for bid submission.
8. All bidders are required to quote their item rates excluding Goods and Service Tax (GST) and all taxes falling within purview of GST-Act 2017 but including labour cess, royalty etc. Payment of GST and required deductions in this reference will be made as per prevailing rules.
9. Payment shall be done on back to back basis on receiving the same from client Uttarakhand Rural Road Development Agency (URRDA).
10. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidder of any bid updates, the Employer shall not be liable for any information not received by the bidder. SECTION-1: INSTRUCTIONS TO BIDDERS

1.0 Online Bids are hereby invited by Executive Director (Civil Design), WAPCOS Limited, Gurugram, Haryana on behalf of Uttarakhand Rural Road Development Agency (URRDA) (hereinafter referred to as “Employer”) from reputed and experienced firms/contractor registered in Class-A or above with PWD/CPWD or equivalent department (hereinafter referred to as “Bidder”) for **Special Maintenance Work for Birtha to Taraswar Motor Road, Length-5.18 Km. Block-Tarikhet, Distt. Almora**” as mentioned in the NIT. Any kind of JV / Consortium is not allowed for this work.

2.0 Bid Validity

The offer(s) shall be valid for a period of 90 (Ninety days) from the date of opening the tender. Conditional bids shall be rejected.

3.0 Scope of Work

This motor road was constructed under Pradhan Mantri Gram Sadak Yojna (PMGSY) Scheme. This road was damaged at several places during the heavy rain occurred (Deviya Aapda) in the project area. The Scope of work includes Construction of Protection Works (Breast wall and Retaining Wall) as specified in the drawing and estimate and instructed by PIU In-charge suitable as per site conditions. Rates shall be quoted by the interested bidder in the prescribed format of BOQ only including all construction and labour charges for execution of the work at site. Payment shall be made to the contractor only on the basis of actual execution/measurements of work at site. Running bill shall be made as per actual progress of work at site. All Payments shall be made to contractor on Back-to-Back basis only on availability of funds/Receiving from the client.

4.0 Site Visit

The Bidder, at his own cost, responsibility and risk, is required to visit, examine and familiarize himself with the site of works. The bidder acknowledges that prior to the submission of the bid, the Bidder has, after a complete and careful examination, made an independent evaluation and understanding of the scope of the work, specifications and standards of design, site local conditions, availability of approaches to the site etc.

A Site Visit Certificate, duly issued by the Resident Engineer of PIU of WAPCOS, is required to submit by the bidder along with his bid, failing which, his bid shall not be considered to evaluation and shall be out rightly be rejected.

5.0 Estimated Cost of Work

Sanctioned Cost of the work is **Rs. 22.88 Lacs** excluding GST. Quantities have been assessed on the basis of damages caused at site and sanctioned from project authority Uttarakhand Rural Road Development Authority (URRDA).

6.0 Essential Qualification Criteria

- a. Bidders must be registered in Class A or above with PWD/CPWD or equivalent department. Registration Certificate shall be provided by the bidder along with his Bid.

- b. Bidder must have experience of Construction of Road / Protection Works with-in last 7 Years in the following manner:
- One (01) Similar executed work costing not less than 80% of the estimated cost of work.
- or
- Two (02) Similar executed works of order value each not less than 50% of the estimated cost of work.
- or
- Three (03) similar executed works of order value not less than 40% of the estimated cost of work.
- As a proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
- c. Bidder must have valid PAN and GST registration number.
- d. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3 consecutive Financial Years.
- e. The bidder should not have incurred any loss in more than 2 years in last five financial years, attested by the independent Chartered Accountant with UDIN number.

7.0 Bid Document Fee and Earnest Money Deposit

Bid Document is available online on the website <https://www.pmgstendersuk.gov.in>. However Bid Fee of Rs. 2,000/- shall be deposited by the bidder in the form of Demand Draft issued by any scheduled commercial bank in favour of WAPCOS Limited and payable at New Delhi/Gurgaon.

The bidders are requested to submit the **Bid Security / Earnest Money Deposit of Rs. 45,760/-** with his Bid, failing which his bid shall out rightly be rejected. EMD shall be submitted in the form of Fixed Deposit Receipt (FDR) only of a scheduled commercial bank in favor of/duly pledged to **WAPCOS Limited**, Sector-18, Gurgaon, Haryana payable at Delhi/Gurgaon. EMD shall be valid for minimum 90 Days beyond the validity of bid.

8.0 Submission of Bid

Bids shall be submitted online and all tendering process will be completed on the Uttarakhand PMGSY online tendering portal <https://www.pmgstendersuk.gov.in>.

Technical and Financial Bids shall be submitted online upto the specified last date and time of bid submission.

The bidder shall submit as Part-I, marked as Technical Bid and Part-II, marked as Financial Bid. All the documents are required to be counter signed by the bidder.

Hard copy of the bid along with following documents shall be submitted to the office address as mentioned in the NOTICE INVITING TENDER (NIT).

- Affidavit for correctness of information provided in the bid document on a non-judicial stamp paper of Rs.10/- and shall be attested by Magistrate/ Sub-Judge/ Notary Public
- Bid Fee in Original

- Bid Validity on Rs. 100/- Non-Judicial Stamp Paper with Rs. 1/- revenue stamp
- Bid Security / Earnest Money Deposit in Original (FDR)
- Bank Solvency Certificate

Aforementioned documents are required to be submitted in original up to specified date and time mentioned in the NIT either by registered post/ courier service or by hand, failing which the bid will be declared as non- responsive. WAPCOS shall not be responsible for any postal delay on any account. In case date of submission happens to be holiday, then documents may be submitted on next working day.

9.0 Technical Bid

The Technical Bid submission forms are enclosed as Schedule-A respectively.

9.1 Bidders shall submit the bid in the formats provided in the Bid Document. Bid shall include the following documents/reports:

1. Contractor's Registration Certificates
2. Bidder must have valid PAN and GST Number. Copy of PAN Card copy and GST Registration shall be provided by the bidder.
3. Affidavit for correctness of information provided in the bid on a non-judicial stamp paper of Rs.10/- and shall be attested by Magistrate/ Sub-Judge/ Notary Public)
4. Bid Validity on Rs. 100/- non judicial stamp paper with Rs. 1.00 Revenue ticket.
5. Bid Fee & EMD Copy
6. Bidder must have experience of construction of Road/Protection Works with-in last 7 Years. In proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
7. Bank Solvency Certificate 40% to the estimated cost (**Rs. 9.16 Lacs**) of work and duly addressed to the Employer and having work name is to be submitted by the bidder along with his Technical Bid. Solvency Certificate must have been issued after the date of publication of NIT & be addressed to the tendering authority quoting the name of work.

9. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3 consecutive Financial Years. In this regard, Chartered Accountant Certificate with UDIN shall be submitted by the bidder.
10. Turnover, Profit, Net Worth certificates must be certified by the statutory auditor of the

firm/company. Any such certificates must carry the UDIN (Unique Document Identification Number)

11. The bidder should not have incurred any loss in more than 2 years in last five financial years, attested by the independent Chartered Accountant.

12. Counter Signed copy of this document as a token of acceptance of the Terms & Conditions

9.2 WAPCOS reserves the right to verify all statements, information and documents, submitted by the Agency in the Bid. Any such verification or the lack of such verification by the WAPCOS to undertake such verification shall not relieve the Agency of its obligations or liabilities hereunder nor will it affect any rights of WAPCOS there under.

10.0 Financial Bid

10.1 The Agency should quote considering all the items as listed in the **Scope of Works**. The quoted amount shall be inclusive of all prevalent taxes in the country. Rates shall be quoted by the interested bidder in the prescribed format of Bill of Quantities provided along with Bid Document only.

10.2 The quoted rates/amounts shall cover the costs of executing all activities defined in scope of work. The quoted rates/amounts shall cover costs of remuneration, accommodation, lodging, boarding, transportation, insurance, equipment, material, and other expenses related to the Agency's staff/manpower and the works to be executed. The Agency shall not require or demand any other reward or compensation, either in the form of currency or in other forms, from WAPCOS. All the taxes/statutory duties etc. except GST required in the place of work shall be borne by the Agency.

10.3 The quoted rates/amounts shall be deemed to be firm throughout the project till the completion of work and shall not be subject to any adjustment due to increase in price of materials, utilities, taxes, duties etc. or any other input for performance of work and the contract.

10.4 The Financial Bid submission forms are enclosed as Schedule-B respectively that shall be filled and submitted by the bidder in separate section Part-II: Financial Bid along with his bid within the specified date and time as mentioned in the NIQ.

11.0 Time of Completion

The time period for the work is 4 months from the Date of Start of the work. Payment shall be made on the basis of actual progress at site and after receiving the funds/approval from the client Uttarakhand Rural Roads Development Agency (URRDA).

12.0 Performance Security, Additional Performance Security & Security Deposit

Performance Security at the rate of 5% of the Contract Price shall be provided by the contractor to the employer at the time of signing of contract in the form of FDR/Performance Bank Guarantee from the nationalized or scheduled commercial banks acceptable to the employer. No Performance shall be deducted from the running bill.

Security Deposit shall remain at the rate of 5% of the Contract Price that shall be deducted from the running bill of the contractor, as per the applicable GCC GPW FORM-9 of PWD

Uttarakhand. All other Terms and Conditions regarding release shall be followed as per GPW FORM-9.

13.0 Payment Terms

Payment to the contractor is totally based on the actual execution of the work at site. Payment shall be made to the contractor only after completion of work at site on back-to-back basis on receiving the same from the client Uttarakhand Rural Roads Development Agency (URRDA) depending on availability of funds and authorization thereof.

The Associate/Sub-Contractor/Sub Consultant acknowledges that under the present Contract/Agreement/Work Order/Arrangement, WAPCOS is only working as intermediary between client Uttarakhand Rural Road Development Agency (URRDA) being Principal Employer/Client and Associate/Sub-Contractor/Sub-Consultant. Thus the Associate/Sub-Contractor/Sub-Consultant unconditionally acknowledges that the payments under the present Contract/Agreement/Work Order/Arrangement shall be made proportionately by WAPCOS only on back-to-back basis i.e. after 21 days subject to receipt of payments from client URRDA being Principal Employer/Client. The Associate/Sub-Contractor/Sub-Consultant also unconditionally agree that in the event the payment or part thereof, under the present Contract/Agreement/Work Order/Arrangement is not received from client URRDA (Principal Employer/Client), then WAPCOS &/or any of its Employee/Officer shall not be responsible to pay any amount to Associate/Sub-Contractor/Sub-Consultant. The said condition shall supersede any and all other conditions of Contract/Agreement/Work Order/Arrangement between the parties.

14.0 Price Escalation & Variation

No Price Escalation shall be allowed for the quoted rates of the bidder throughout the period of completion of the work. As the client URRDA has sanctioned the cost for the Special Maintenance work, no variation in quantities shall be allowed exceeding the sanctioned cost of the work.

15.0 Penalty / Liquidated Damages

If the contractor fails to maintain the required progress to complete the work and clear the site on or before the project completion period or extended date of completion, he shall pay or allow WAPCOS to deduct penalty as per Clause 4: Compensation of Delay of GCC pg. 3 GPW FORM-9, Government of Uttarakhand.

16.0 Arbitration

16.1 Resolution of Disputes

Except where otherwise provided in the contract, all questions and disputes relating to the work or the execution or failure to execute the same whether arising during the progress of the work or after the cancellation, termination, completion or abandonment thereof shall be dealt with as mentioned hereinafter:

If the Selected Agency considers any work or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable and is resulting in a dispute, it shall be referred to the Nodal Officer from WAPCOS who shall, within a period of thirty days after being requested by the Selected Agency to do so, give written decision to the Selected Agency. Upon receipt of the written decision of the Nodal Officer, the Selected Agency shall promptly proceed without delay to comply with such decision.

16.2 Adjudication of Disputes

Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled through following mechanism :-

- a. Firstly, the aggrieved party shall write a letter to the other party detailing its grievances and calling upon the other party to amicably resolve the dispute by convening a joint meeting. Accordingly, the parties as per their convenience shall jointly convene the said meeting(s), wherein minutes of the said meeting(s) shall be prepared and countersigned by all the parties. It is mandatory to prepare minutes of meeting(s) and to be countersigned by all the parties, irrespective of the outcome of the said meeting(s).
 - b. In the event the parties are unable to reach on any settlement in the said meeting(s), then the aggrieved party shall mandatory resort to pre-litigation mediation mechanism with Delhi High Court Mediation Cell, New Delhi.
 - c. It is only upon failure of the pre-litigation mediation mechanism with Delhi High Court Mediation Cell, then the aggrieved party shall resort to resolution of disputes through arbitration of a Sole Arbitrator. The appointing authority of Sole Arbitrator is CMD, WAPCOS Limited, to which neither of the parties have any objection nor they shall ever object.
 - d. Subject to the parties agreeing otherwise, the Arbitration proceedings shall be conducted in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996 (amended as on date).
 - e. It is also acknowledged and accepted that WAPCOS is only working as Intermediary between the Associate/Sub-Consultant/ Sub-Contractor and the Client, thus in the event, any dispute arises under the present agreement and referred to Arbitration for adjudication, then subject to corresponding clause in the Contract/ Agreement/ Work Order/ Arrangement between Client & WAPCOS, Client shall also be made party to the said Arbitration proceedings. Also, the award including costs if any passed against WAPCOS and costs incurred in the proceedings shall be the sole responsibility of Principle Employer/ Client. The said clause if found inapplicable, even then the other terms of the Arbitration Clause shall survive and shall be acted upon.
 - f. The place/seat of arbitration shall be Delhi and award whether interim or final, shall be made, and shall be deemed for all purpose between the parties to be made, in Delhi. The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian Law. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
 - g. The contract and any dispute or claim arising out of or in connection with it or its subject matter of formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India and the Parties submit to sole & exclusive jurisdiction of courts at Delhi.
- 17.0** Incomplete tenders, conditional tenders, tenders received after the stipulated time shall be summarily rejected.
- 18.0** Employer reserves the right to reject any or all bids without assigning any reason.

Conditions to withheld the amount in case of non- achievement of milestone:-
