- 1.2 Principal Employer/Owner/Client means of Odisha State ST & SC Development, M&BCW Department Shall include their Legal representatives, nominees, employees and Officials.
- 1.3 Employer shall mean “WAPCOS Limited”, A Government of India undertaking- Ministry of Jal Shakti, for execution of the Work / Project and WAPCOS is working as Executing agency on behalf of Principal Employer/Owner/Client
- 1.4 All Bidders are hereby cautioned that Bids containing any deviation or reservation as described in Clauses of “Instructions to Bidders” shall be considered as non-responsive and shall be summarily rejected.
- 1.5 WAPCOS Ltd. reserves the right to accept or reject any or all bids without assigning any reasons. No Bidder shall have any cause of action or claim against the WAPCOS Ltd. for rejection of its Bid and will not be bound to accept the lowest or any other tender.

- 1.9 The provisions of revised ‘**Public Procurement (Preference to Make in India) Order 2017-Revision**’ issued by Department of Industrial Policy and Promotion under Ministry of Commerce and Industry vide letter no.-P45021/2/2017-PP (BE-II) as amended on 16.09.2020 shall be applicable to the bidding process and award of the contract shall be done accordingly. In this connection, the minimum local content shall be 50% and the margin of purchase preference shall be 20%.
